Sealed quotations are invited from interested firms/agencies for providing the services of pest controlling in the premises of the office of Staff Selection Commission (Eastern Region), Govt. of India, Department of Personnel & Training, located at 8<sup>th</sup> Floor, 1<sup>st</sup> MSO Building, Nizam Palace, 234/4, A.J.C. Bose Road, Kolkata – 700020 initially for **one year period** which may be extended or curtailed as per requirement of this office as per Tender Documents.

2. The Tenderers can inspect the office premises on all working days (from Monday to Friday) from 12 noon of 18<sup>th</sup> January 2023 to 10:00 A.M of 30<sup>th</sup> January 2023.
3. The sealed tender superscribed as “Limited Tender for pest control service” along with name and address of bidder should be submitted **on or before 12:00 Noon of 30<sup>th</sup> January 2023** in the Administration Section of this Office at the above address. No tender received after 12:00 Noon of 30<sup>th</sup> January 2023 would be entertained. The Tenders will be opened on the same day i.e. at **03:00 P.M of 30<sup>th</sup> January 2023** in this Office premises in the presence of the representatives of the Tenderers.
4. The Terms & Conditions etc. governing the Tender Notice and Tender Form are given along with this Notice Inviting Tender Enquiry.

## TENDER DOCUMENTS AND TERMS AND CONDITIONS

### A. SCOPE OF WORK:

- a) Jobs to be done **ONCE A WEEK ON EVERY FRIDAY after 06:00 P.M.** in this Office premises i.e. premises of the Staff Selection Commission (Eastern Region), Govt. of India.
- b) Total area of this Office premises includes an area of about 5600 sq. ft. at the 8<sup>th</sup> floor, 1<sup>st</sup> MSO Building, 'Nizam Palace', 234/4, A.J.C. Bose Road, Kolkata-700020 and about 1100 sq. ft. at the 9<sup>th</sup> floor of the same building.

### B. OUR REQUIREMENTS:

- a) This office requires pest control, rodent and disinfection services at this Office premises, covering the area as mentioned at A(b) above.
- b) The scope of the contract includes carrying out general insect/pest control services at this Office premises for cockroaches extermination, rodent control, mosquito, rats and fly control services.
- c) The agency should bring the required pesticides or chemicals, spray them through a spray gun or place them if they are dry cubes or carry out such chemical treatment through insecticide sprays/injections or other standard Pest Control practices. Only company made chemicals and herbal powder mixed with water are to be used.
- d) Jobs to be done once a week as mentioned above.

### C. TERMS & CONDITIONS:-

- (i) The Tenders should be addressed to the Regional Director, Staff Selection Commission (ER), 8<sup>th</sup> Floor, 1<sup>st</sup> MSO Building, Nizam Palace, 234/4, AJC Bose Road, Kolkata – 700020 and should be superscribed as “Limited Tender for providing the services of Pest Control”.
- (ii) The Tenders in the **prescribed Proforma as Annexure-A**, duly sealed, should reach this office by **30<sup>th</sup> January 2023 on or before 12:00 Noon**; after that, no Tender will be accepted. The Tender should be filled as per given format only.
- (iii) The contract to be entered into shall remain valid for one year from the date of signing of Agreement and may be extended with mutual consent. However, the contract can be terminated at any time even during its currency, in case the Commission is not satisfied with the performance of pest controlling work.
- (iv) **No conditional Tender** shall be accepted.

- (v) The rates quoted should remain valid for complete contract period including any extension period (if extended with mutual consent). The Total quoted amount should be written both in figures and in words.
  - (vii) Quotations, which do not comply with the above conditions, are liable to be rejected.
  - (viii) If the successful vendor leaves the job before expiry of the contract period or work done by such vendor is not found to be satisfactory, this Office reserves the right to terminate the contract.
  - (ix) A register will be maintained by this Office, in which the worker of the service provider will put his attendance on the day of his work, in presence of the official of this office on duty.
  - (x) Rate quoted will be all inclusive taxes. The Commission will not pay any kind of Taxes separately on the rates quoted by the firm/vendor.
  - (xi) The SSC(ER) reserves the right to reject any or all the tenders without assigning any reason thereof and is under no obligation to inform the affected bidder or bidders of the grounds of SSC(ER)'s action.
  - (xii) Any overwriting in the Tender/late submission of Tender will not be entertained.
  - (xiii) All pages of documents attached with the bid form should be self attested by the authorised signatory/bidder.
  - (xiv) **The acceptance of the offer made by the bidder will be deemed as a contract.**

**D. SETTLEMENT OF DISPUTE:** The Commission and the contracted Vendor shall make every effort to resolve amicably by direct negotiation any disagreement or dispute or misunderstanding arising between them in connection with the service rendered and claims of payments etc. Any unresolved dispute would be referred to a mutually agreed arbitrator or as to be decided by the Regional Director, SSC (ER) in case of disagreement. Further, all disputes are subject to jurisdiction of Calcutta High Court.

E. **EARNEST MONEY DEPOSIT (EMD):**

In terms of Rule 170(iii) of GFR 2017, Bid Security Declaration should be signed by the bidders accepting that if they withdraw or modify their bids during the period of validity etc. they will be suspended for the time specified in the tender documents. No provisions regarding Bid Security should be kept in the Bid Documents, and only provision for Bid Security Declaration should be kept in the Bid documents.

F. **PERFORMANCE SECURITY:**

- (i) In terms of Department of Expenditure's OM No.F.9/4/2020-PPD dated 12.11.2020, the successful tenderer will have to deposit Performance Security of 3% of the value of the work for each occasion in the form of Fixed Deposit Receipt/Bank Guarantee from a Nationalised Bank in an acceptable form in favour of Regional Director, Staff Selection Commission (Eastern Region).
- (ii) Performance Security will be refunded to the tenderer after satisfactory completion of the assigned tasks.
- (iii) Performance Security will be forfeited if the tenderer fails to perform any of the terms & conditions of the contract, without prejudice to such other action including blacklisting by SSC(ER) if deemed fit.

G. **MODE OF PAYMENT:**

The payment shall be made to the Service Provider on quarterly basis on submission of pre-receipted bill in triplicate. In case of any delay in submission of the bill by the service provider this office will not be responsible for any delay in payment. Payment will be made by NEFT or electronically as per standard government procedure.
