 - (i) Master Degree in Physics or Applied Physics or Computer Science or Electronics or Forensic Science with Physics as one of the subjects or papers during all the three years of Bachelor of Science level from a recognized university. OR
 - (ii) Bachelor of Engineering or B.Tech (Civil or Electrical or Mechanical or Electronics or Telecommunication or Computer Science or Instrumentation) or Computer Science and Engineering (CSE) or Electronics and Communication Engineering (ECE) or Information Technology or Electronics or Electrical and Electronics (EEE) from a recognized University.

(b) The Crucial date for determining age-limit and possession of Essential Qualification (EQ)/ Experience is 01.01.2021. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 25.10.2021.
