In continuation to the result of Computer Based Examination for Phase-VIII/2020/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Instructor (Stenography) in pursuance of Para 17.23 of the Notice of Phase-VIII/2020/Selection Posts, which are as under:

“In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called only for one more time, at the discretion of the Commission for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5.”

In this regard, it is stated that additional 03 candidates have provisionally qualified for next stage of Scrutiny process for the post of Instructor (Stenography) [Post Category No. ER13220] in National Career Service Centre for SC/ST.
