(i) Master's Degree in Botany or Zoology or Microbiology or Biotechnology or Biochemistry or Physical Anthropology or Genetics or Forensic Science with Botany or Zoology as one of the subject or papers during all the three years of Bachelor of Science level from a recognized University; OR (ii) B.E or B.Tech in Biochemistry from recognized University

(b) The Crucial date for determining age-limit and possession of Essential Qualification (EQ)/ Experience is 01.01.2021. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 25.10.2021.
