(a) Essential Qualification (EQ) attached to post is as follows:

Master's Degree in Chemistry or Biochemistry or Pharmacology or Pharmacy or Forensic Science with Chemistry as one of the subjects or papers during all the three years of Bachelor of Science Level from a recognized university.
