Subject: Scrutiny Status of candidates in respect of recruitment of 03 (02-UR & 01-SC) vacancies for the post of Pharmacist-cum-Clerk (Homeopathic) advertised vide Post Category No. ER12122 of Advt. No. Phase-X/2022/Selection Posts- reg.

In continuation to the result of Computer Based Examination for Phase-X/2022/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Pharmacist-cum-Clerk (Homeopathic) in pursuance of Para 18.22 of the Notice of Phase-X/2022/Selection Posts, which is as under:

“In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called **only for one more time, at the discretion of the Commission** for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5.”

2. Essential Qualification for the post of Pharmacist-cum-Clerk (Homeopathic) [Post Category No. ER12122] is as follows:

- 12th class passed or equivalent with Physics, Chemistry or Biology from a recognized Board or University;
- Diploma or Certificate course in Homoeopathic Pharmacy of at least one year duration from a recognized institution

In this regard, it is stated that additional 20 candidates have provisionally qualified for next stage of Scrutiny process for the post of Pharmacist-cum-Clerk (Homeopathic) [Post Category No. ER12122] in Central Government Health Scheme, Kolkata.
