Essential Qualification (EQ) attached to post is as follows:

- (i) 10th Class pass from a recognized Board;
 - (ii) One year Certificate course from Industrial Training Institute with one year apprenticeship in Government Press, or Two years apprenticeship in Government Printing Press, or Certificate in Binding with at least three years practical experience of high class binding work, manual binding or repair or handling of rare fragile manuscripts in Commercial or Government Press
2. The Crucial date for determining of age-limit and possession of Essential Qualifications (EQs)/ Experience will be 01-01-2022 and 13.06.2022 respectively. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 13.06.2022.
