**CORRIGENDUM**

**Subject: Clarification Regarding Exemption from Typing Test for PWD Candidates – Combined Higher Secondary Level (Tier-II) Examination, 2024**

File No. 10/20/2024-Exam.I - It is hereby informed that, in reference to the earlier notice dated 25/10/2024 regarding the exemption from the Typing Test for Persons with Disabilities (PwD) candidates in the Combined Higher Secondary Level (Tier-II) Examination, 2024, the following clarifications and amendments are being issued:

**Clarification on PwD Category Eligibility:** It is clarified that the term 'Persons with Disability (PwD)', in this case, does not cover those who are visually handicapped or who are hearing handicapped but covers only those whose physical disability permanently prevents them from typing, as stated in the Corrigendum-I [F. No. HQ-PPII010/1/2024-PP\_II (E file no. 8442)] dated 27/08/2024 issued by the SSC(HQ). Other content of earlier notice dated 25/10/2024 will remain unchanged.

This corrigendum is issued to ensure clarity regarding the exemption process for PwD candidates. All candidates concerned are advised to carefully review the eligibility criteria.

**Paragraph 5 of the Notice dated 25/10/2024 is reiterated:** Candidates are required to produce all supporting documents (Medical Certificate [Annexure XIV], PwD Certificate [Annexures XI to XIII, as applicable], and the Undertaking), in original along with one set of photocopies on the day of exam at the venue. If any candidate fails to produce the same during the Typing Test, their candidature for the Combined Higher Secondary Level Examination, 2024 shall be treated as **cancelled and shall forfeit their right to the post and claim relating thereto.**

**COMBINED HIGHER SECONDARY (10+2) LEVEL EXAMINATION – 2024**

**CORRIGENDUM - I**

**F. No. HQ-PPII010/1/2024-PP II (E file no. 8442)** – Candidates may refer to the Notice of the Combined Higher Secondary (10+2) Level Examination – 2024 dated 08.04.2024. Para 13.9.7.7.7 of the *ibid* Notice may be read as:-

“13.9.7.7.7 Persons with Disability (PwD), who are otherwise qualified to hold the post(s) and who are certified as being unable to type by the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution, may be exempted from passing the typing test. Such certificate shall be submitted in the prescribed format (**Annexure-XIV**). The term 'Persons with Disability (PwD)', in this case, does not cover those who are visually handicapped or who are hearing handicapped but covers only those whose physical disability permanently prevents them from typing. In addition, such candidates must substantiate their claim by furnishing the relevant Medical Certificate in the prescribed format as per **Annexure-XI to Annexure-XIII** of the Notice of Examination, as applicable, at the time of Typing Test. Otherwise their claim for seeking exemption from Typing Test will not be entertained by the Commission. ”
