The candidates of Skill Test in Hindi Language can use Inscript OR Remington keyboard outlays only. Keyboard outlays once opted for skill test cannot be changed during the examination.

Candidates are advised to take due care while applying for this examination and opting Centre for the said purpose as request for change of Centre shall not be entertained after submission of application. Candidates whose offices are located at West Bengal, Jharkhand, Odisha, Sikkim and Andaman & Nicobar Islands can apply for this examination from SSC(EasternRegion).
