BOSE ROAD, KOLKATA-700020 on the schedule date, batch & time as mentioned in the aforesaid link for verification of your documents. If you fail to appear in the Document verification on the schedule date, batch & time, your candidature will be treated as cancelled without any further notice.
  - You are requested to invariably bring all the Original Certificates & documents, as applicable as per eligibility condition(s) attached to the post(s) applied for, for producing the same before the Commission during the Document verification session, failing which, your candidature will be liable to be cancelled. You are also requested to bring original certificate of the following documents & submit one set of its self attested copies:-

a) Matriculation Certificate;

b) Mark-sheets/Certificates/Experience Certificate (if applicable) as per the Essential Qualifications of the Post applied for;
