2. It is requested that before issuing offer of appointment the following particulars/documents of the candidates may be checked at your end-

- i. Date of birth certificate/matriculation certificate
- ii. Certificates relating to Essential Qualification as on date prescribed in the notice of the Examination
- iii. SC/ST/OBC/Ex-S/PH certificates, if any, issued by the competent authority in the prescribed format
- iv. Candidate's claim in respect of age relaxation, if any
- v. In respect of OBC candidates, guidelines regarding creamy layer status may be strictly followed
- vi. Candidate's result, rank number and category may be checked with the result sheet sent/available in the Commission's website i.e. www.sscer.org.

3. In addition to the above, prescribed pre-appointment formalities such as character and antecedent verification and medical examination of the candidates may also be completed at your end as per the prevalent Rules and Regulations.

4. It is requested that the appointing authority must verify the SC/ST/OBC and other status claimed by the candidates in application with the documents submitted by them and satisfying themselves in this regard.

5. The guidelines issued vide DOPT O.M. No.9/23/71-Estt.(D) dated 06-6-1978 and as amended vide DOPT O.M. No.35015/2/93-Estt.(d) dated 09-8-1985 in respect of issuing appointments by Ministries/Departments of Government of India may also be followed.

6. Receipt of the Dossiers may be acknowledged.

7. In this context, it is informed that <u>03-OBC vacancies for the post of Assistant Archivist (General)</u> could not be filled up due to non-availability of suitable/eligible OBC candidates. You are requested to submit a fresh requisition in this regard for re-advertisement of unfilled 03-OBC vacancies. The requisition may be submitted clearly mentioning that the "the Recruitment/Selection shall be subject to outcome of W.P. (C) No.5524/2018 field by Ms. Neelam and others Vs. Union of India in the Hon'ble High Court, Delhi".
