- 2. Final Merit List has been prepared on the basis of Performance in Computer Based Mode (CBM) Examination for Matric Level posts under Phase-VI/2018/Selection Posts Recruitment held on 16th, 17th & 18th January, 2019.
- 3. Scores in the CBM Examination of those candidates who did not appeared for the Document Verification or who do not fulfilled all the Criteria as per the Notice of Recruitment, have not been considered.
