(ii) Two year experience as a Shift-in-charge/ Dyer/Bleacher /Finisher/Dyeing Master/ Printing Master/Textile Processing Assistant/Laboratory Technician/ Demonstrator (Processing)/ Supervisor, handling work relating to bleaching or dyeing or Printing or finishing etc. in a textile processing factory/ processing or dye house/ dyeing laboratory/handloom establishment; **OR**

(B) (i) Diploma in Handloom Technology or Diploma in Handloom and Textile Technology from a recognized University or Institute;

(ii) Post Diploma in Textile Chemistry or Textile Processing from a recognized University or Institute;

(iii) Two year experience as a Shift-in-charge/Dyer/ Bleacher/Finisher/Dyeing Master/ Printing Master/ Textile Processing Assistant/Lab Technician/ Demonstrator (Processing)/ Supervisor, handling work relating to Bleaching or dyeing or printing or finishing in a textile processing factory/processing or dye house/dyeing laboratory/handloom establishment.

(b) The Crucial date for determining age-limit and possession of Essential Qualification (EQ)/ Experience is 01.01.2020. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 20.03.2020.
