The candidates of Special Recruitment Drive for Persons with Disabilities to the Post of Multi Tasking (Non-Technical) Staff in Different States and Union Territories 2015, who have applied in SSC, Eastern Region and have been declared qualified in written part of the examination are directed to report at the office of Staff Selection Commission (Eastern Region), 8th floor, 1st MSO Building, Nizam Palace, 234/4, A.J.C. Bose Road, Kolkata – 700020, along with the documents mentioned below as per the schedule given at the end of this notice:-

- i) Matriculation/equivalent certificate and mark sheet, issued by the State/Central Education Board (and <u>not</u> by the Principal/Headmaster of the School/Institution where studied), showing <u>date of birth</u> (in Christian Era) in support of Essential Qualification and date of birth as claimed in application. Date of Birth as recorded in the Matriculation/Secondary Examination Certificate or an equivalent certificate available on the date of submission of application will only be accepted by the Commission for determining the age and no subsequent request for its change will be considered or granted. The certificate/mark-sheet should contain the date of publication of the result of the examination. <u>If the certificate/mark-sheet</u> sheet does not contain the date of publication of result a separate certificate from the competent authority stating the date of publication of result should be submitted failing which the candidate would not be considered for subsequent stages of the recruitment.
- ii) Certificates/documents (issued by the Competent Authorities and in the format as prescribed in the Notice of Examination) in support of claim, if any, of belonging to the categories of SC/ST/OBC/PH. Certificates in any other format will not be accepted. OBC Certificate for the status of Creamy Layer issued between 24.11.2012 to 20.05.2016 only will be accepted.
- iii) Certificate from the Office/Department [if claiming age relaxation as a Central Govt. Civilian Employee (CGCE)] in support of the claim of completion of three years of regular service on the closing date, i.e. 23.11.2015 and also Official/Departmental endorsement/certificate with particulars, duly verified by office. (The candidate will not be eligible for age relaxation admissible to the Central Govt. Civilian Employee, if he/she has ceased to be in Govt. service). The candidate will also be required to submit No Objection Certificate (NOC) from the employer for obtaining age relaxation as CGCE employee.
- iv) If a person with disability is entitled to age concession by virtue of being a Central Government Employee, concession to him/her will be admissible either under PH category or under Central Government Employee, whichever is beneficial to the candidate.

Relaxation of age limit would be permissible to such persons who have a minimum of 40% disability.

- v) Photo Identity Card in original like Voter Card, Driving License, PAN Card, Aadhaar Card, Passport etc.
- vi) Three passport size photographs.

<u>Attendance</u> of all the candidates for document verification on the date and time mentioned in the schedule given below <u>is compulsory</u>. If any candidate does not report for document verification on the scheduled date and time, he/she will not be considered for the subsequent stages of the examination and no further opportunity will be given to him/her for appearing in document verification. The candidature of the candidate is subject to the fulfillment of eligibility conditions as determined on the basis of the documents to be produced at the time of document verification. Call letters for document verification have been issued to all candidates by e-mail. The call letters will not be sent by post to the candidates. They will also be allowed to appear in the document verification on production of print out of this notice along with other requisite documents.
